### **Round Table Business**

The First Defenders Civil War Round Table met on May 11, 2021, at Giannotti's Country Manor. Twenty-seven members were present when President Craig Breneiser called the meeting to order at 6:17 p.m. A touching prayer originally delivered by the chaplain of the 1<sup>st</sup> Tennessee Regiment was offered by Ev Binns followed by President Breneiser leading the Pledge of Allegiance. Dinner was then served.

At 7:45 p.m., the evening's presenter, Tom Huntingdon began his program, "Searching for George Gordan Meade," virtually. Seven additional members joined the program online. A business meeting followed the program.

#### **Treasurer's Report**

Treasurer Tim Antosy reported a balance in the treasury of \$3,671.75 as of May 11, 2021. The Shenandoah Valley Foundation was offering \$50: \$1 for land available at Second Winchester. Mark suggested that we take advantage of these generous offers by sending \$150 to each association. It was moved and seconded and approved by the membership.

# **September Program**

### "I am too late." - Joe Johnston & the Battle of Jackson

#### featuring Chris Mackowski

"I am too late," Joe Johnston declared as soon as he set foot in the Mississippi capital of Jackson—a city he'd been sent to defend under direct orders

from Confederate President Jefferson Davis, a native Mississippian. Ulysses S. Grant's army was lurking somewhere in the state's interior with an eye on a strike toward the river citadel of Vicksburg, but Jackson the state's commercial, transportation, and political hub—would suddenly become a tempting target with Johnston in town. Often overlooked in the larger sweep of the Vicksburg Campaign, the May 14, 1863, the battle of Jackson, Mississippi, carried enormous consequences for both army commanders.



Chris Mackowski, Ph.D., is a professor of journalism and mass



communication at St. Bonaventure University and historian-inresidence at Stevenson Ridge, a historic property on the Spotsylvania battlefield. He also volunteers at Fredericksburg & Spotsylvania National Military Park, where he still gives tours at four major Civil War battlefields (Fredericksburg, Chancellorsville, Wilderness, and Spotsylvania), as well as at the building where Stonewall Jackson died. Chris is co-founder of Emerging Civil War,

and has authored, co-authored or edited numerous Civil War books. A popular and much-sought speaker, Chris has been the lead-off presenter for the First Defenders for the past four campaigns.

**mon·u·ment:** /'mänyəmənt/ *noun* a statue, building, or other structure erected to commemorate a famous or notable person or event

So, based on this dictionary definition, should we be surprised and, I daresay offended, if a desire to commemorate "a famous or notable person" should change over time and as such person recedes into memory or is overtaken by a new way of thinking? Germany has disposed of virtually all vestiges of the Third Reich and Russia has similarly removed many icons of its USSR days. Is it time for our Confederate monumentation to also fade from the scene?

There stands in mid-town (!) Andersonville at the intersection of East Church and South Oglethorpe Streets a monument to a man who was convicted of being a war criminal. Henry Wirz was the notorious (some say "beleaguered") commandant of Camp Sumter where two of my ancestors spent time as guests of the Confederate government and where one remains in eternal sleep since 1864. According to modern dicta, I should be righteously indignant and demand the removal of this abomination.

Perhaps, though, it is better we should re-think the subjects of such monuments. While it may be (past) time to commit Lost Cause dogma to the "picklocks of biographers," there is still much we can learn from and about the subjects of monuments. Robert E. Lee and his lieutenants may not be quite as noble when viewed through a 21st century prism, but they are important threads in the American fabric. There is much they can yet tell us, some good, some not so good, that is important to how we have developed and continue to develop as a nation and as individuals. Taking them out of public view makes such an opportunity more difficult and much less likely.

Henry Wirz had an impact on me 90 years before I was born. Other than his monument being something of a traffic hazard, I prefer to learn more about him and his influence on my life than seeing his monument relegated to old photographs. His story, and those of others not yet gone, can speak to us still if only we listen.

#### Preservation

Our September speaker, Chris Mackowski is not only Editor and Co-Founder of Emerging Civil War he is also Vice President of Central Virginia Battlefield Trust. This is an organization that has done a lot to preserve the Fredericksburg, Chancellorsville, Wilderness, and Spotsylvania Battlefields. Thank you and the CVBT for all you have done with preserving these battlefields.

With the money raised this month we made two donations. The first donation is to the American Battlefield Trust in the amount of \$100 for their \$28-1 Matching Grant for Gettysburg and Second Winchester. The Trust is looking to save 4 acres of the battlefield from East Cemetery Hill along the Baltimore Pike up to Stevens Knoll. This parcel includes the McKnight House.

The second donation was to the Battle of Franklin Trust in the amount of \$100 to help the Trust with managing Rippavilla. Rippavilla was General John Bell Hood's Headquarters during the Battle of Spring Hill. With both the donation for the American Battlefield Trust and the Battle of Franklin Trust our total contribution this season to date is \$2900. Our season is off to a great start thanks to all of you.

# **October Program**

### Prelude to Gettysburg: the Cavalry Battles of Aldie, Middleburg & Upperville

#### featuring Kevin Pawlak



As Robert E. Lee continued to move north Maryland and Pennsylvania during the summer of 1863, Army of the Potomac commander Joseph Hooker struggled to gain a better understanding of Confederate intentions. Following the cavalry action at Brandy Station, Hooker would still look to his horsemen to find the enemy and develop its intentions. At the same time, Lee would use his cavalry under J.E.B. Stuart to do all that it could to deprive the Union commander of that valuable commodity. The result of this life-and-death chess game resulted in three bloody days of intense cavalry fighting in northern Virginia's Loudoun Valley near the towns of Aldie, Middleburg, and Upperville. Often overshadowed

by the climactic action two weeks later at Gettysburg, these oft-overlooked running battles represent a key chapter in a campaign that saw the northern horsemen meet their southern opponents on more equal terms than ever before.

Kevin Pawlak is a Historic Site Manager for Prince William County's Office of Historic Preservation and a Certified Guide at Antietam National Battlefield and Harpers Ferry National Historical Park. He is the author of four books on the American Civil War.

"Pardon me, is the majority always drunk?" So asked a South Carolinian of his (Confederate) congressman in 1863. Nearly 160 years later, the question, no longer restricted to the majority, still seems relevant.

Hardly a surprise, impeachment resolutions have been filed in the House of Representatives against President Joe Biden. There is no mention of "treason, bribery or other high crimes or misdemeanors" as outlined in the U.S. Constitution, but that seems immaterial when politics are at work.

The Founding Fathers specifically removed "maladministration" as a basis for impeachment during their 1787 deliberations in Philadelphia. Other than, perhaps, George Washington, the 44 men who would attain the highest office in the land certainly had those partisans who could have made a case for "maladministration." Indeed, 15 presidents have been subjected to impeachment investigations or resolutions, and four impeachment trials have been held in our nation's history (including three in our recent lifetimes!). But, did any of these efforts meet the definition found in Article II, Section 4?

Then-U.S. Representative Gerald Ford once opined that impeachable offenses are whatever a majority of the House considered them to be; all they need to do is convince their colleagues to agree with them and subsequently convince two-thirds of the Senate to go along. Can the constitutional safeguards enshrined by the Founders have truly fallen to such a pedestrian level?

Harry Truman was once threatened with impeachment for having the temerity to fire General Douglas MacArthur. This pales next to the number of generals who were shown the door by Abraham Lincoln (who also managed to escape articles of impeachment for brazenly ignoring an order issued by Chief Justice Roger Taney!). Which brings to mind another thought: if "pro" is the opposite of "con," what is the opposite of "progress?"

# **November Program**

### Dr. Mary Edward Walker

#### a living history portrayal by Hallie Vaughan

Mary Edwards Walker stands out as one of the more interesting and unusual personalities of the Civil War era. Born in 1832, she would earn a



medical degree from Syracuse Medical College in 1855 and pursue a profession that was virtually unheard for a "proper" Victorian Age lady. Throughout her 87 years, she would be an abolitionist, prohibitionist, a prisoner of war and a Civil War surgeon. Along the way, she would be the only woman to ever receive the Medal of Honor.

Doctor Walker would volunteer her services to the Union Army at the outbreak of the War, breaking what today we would call a "glass ceiling." She was captured by the Confederates when she crossed enemy lines to treat wounded civilians, and was arrested as a spy. Doctor Walker would remain a "guest" of the Richmond government until finally being exchanged. After Appomattox, she would receive the Medal of Honor, but spend much of her life fighting to keep it.

Hallie Vaughan has been a Berks Countian since age 12. Graduating from Wilson High School, Slippery Rock University and Gratz College, she taught

in the Muhlenberg School District for 35 years during which time she developed an interest in women's history. Hallie has continued doing research on the subject, and has lectured at Alvernia University Seniors College while also presenting to a wide assortment of community and school groups as well as "anyone who wants to listen!" A docent at the Berks History Center, Hallie also volunteers at the Berks County Veterans Affairs Office. She is married and has two sons and four grandchildren.

It is often believed the holiday season was spent comparatively peacefully during the Civil War, and the soldiers would reflect inwardly while engaging in unofficial truces with their adversaries across the lines. While it is true there were no major battles at Christmastide, the War was never far from one's mind.

Abraham Lincoln would spend his first holiday in the White House with his family before sitting down with his advisors in an effort to stave off war with Great Britain following the *Trent Affair* six weeks earlier. A year later, he would be anxiously following the decidedly mixed fortunes of the Army of the Cumberland advancing from Nashville to Murfreesboro and a portion of the Army of the Tennessee approaching the well-defended Chickasaw Bluffs near Vicksburg. By his third Christmas in the Executive Mansion, the President would be planning a goodwill visit to Confederates imprisoned at Point Lookout, Maryland. Still, the war ground on.

In what would become his final White House Christmas, Abraham Lincoln would receive that evening the now famous telegram from Major General Sherman: "I beg to present you, as a Christmas gift, the City of Savannah, with 150 heavy guns and plenty of ammunition, and also about 25,000 bales of cotton."

Overjoyed, the President would reply the next day. "Many, many thanks for your Christmas gift, the capture of Savannah." Lincoln would go on to gratefully acknowledge Sherman and the officers and men of his army, and, combined with George Thomas's recent victory at Nashville, he would biblically write, "...it brings those who sat in darkness to see a great light."

Lincoln's next words, though, were sobering. "But what next?" Despite the joy of the holiday season and clear signs the Union was on the move, the President knew the War still needed to be won and clearly saw that peace would be a challenge, too. As we near the end of a whirlwind 2021...a new administration, the continuing pandemic, an uncertain economy, unrest..., and while wishing everyone a joyous holiday season and blessings for the New Year, we, too, can contemplate Lincoln's inquiry 157 years later: "But, what next?"

The Matching Grant is **\$5.83-\$1**.

The Rucker Ambulance, along with the Wheeling or Rosecrans Ambulance, were the two main types of ambulances used by the Union Army. The Museum is contracting with a company which specializes in this type of work. There is no Matching Grant with this project.

# **December Program**

#### Meade's Pipe Creek Line

featuring Chris Army

In late June 1863 George Meade unexpectedly and suddenly found himself in command of the Army of the Potomac. A battle with the Confederate



Army of Northern Virginia, already on the loose in south-central Pennsylvania, appeared imminent, and there was little time to waste and less time to organize. As he grasped the reins of command, Meade's engineer training was put to the test, and from that he developed a defensive position along Pipe Creek in Carroll County, Maryland. A source of contention both during the imminent Battle of Gettysburg and for years after, veterans and historians have long referred to the "Pipe Creek Line" in an effort to either show Meade as a thoroughly-competent soldier planning for all contingencies or as evidence of cowardice and an unwillingness to cross swords with Robert E. Lee. This presentation will discuss this plan that never came to fruition and which is seldom discussed and (almost) never visited.

Chris Army is a Licensed Battlefield Guide at Gettysburg National Military Park, and has led tours around the Battlefield for groups of all demographics from private car tours to West Point Cadets. Chris is the author of an article for Blue & Gray Magazine about the North Carolinian Brigade of Alfred M. Scales and is currently working on several Gettysburg related projects. Chris co-authored three resource guides on Civil War actions in Culpeper, Virginia, and has served as a co-moderator of Military History Online. A Past Board President of the Adams County Historical Society, Chris is a product instructor for Johnson Controls. He lives with his wife, Connie, in Dover, Pennsylvania.

#### From Tim Antosy...

On October 23 of this year, I was at Fredericksburg, VA, for the first time. I was impressed with Chris Mackowski's tour. At one point we stopped at the Slaughter Pen Farm which, without that part of the Battle, Fredericksburg would not make much sense. That's how important that piece of property is to the understanding of that battle. To show you just how important that property is, the Virginia Central Preservation Group there paid \$12 million for that property. We should all be proud and enthusiastic when we contribute to preservation. It is so important.

The Slaughter Pen Farm was on the left flank of the Union Army and was the place General Meade and his Pennsylvania Volunteers attacked Stonewall Jackson's front, and, for a short time, did hold a part of that flank. If General Franklin had done the right thing and had brought his troops forward, there never would have been the Battle of Fredericksburg and the terrible Union casualties; but, of course, it didn't happen, and Burnside had no other choice except to attack Marye's Heights the way the Union Army did.

To me, one of the most iconic symbols of the Civil War is the wall at Marye's Heights. Of the original 900 yards that the Union Army fought and died on, there is maybe 150 yards left. That is what can happen if we don't keep buying up properties for preservation. I just wanted you all to know how that affected me, and I hope you all continue to contribute to preservation when you can. Thanks.

#### Lee is Trapped and Must Be Taken- Williamsport

#### featuring Richard Schaus

The Pennsylvania Campaign of 1863 reached its climax during the three day Battle of Gettysburg, but would not come to an end for nearly two more weeks. With the Confederates' back to the raging Potomac River at Williamsport, Maryland, Abraham Lincoln counseled, "Lee is Trapped, and Must be Taken." This program covers eleven fateful days after Pickett's Charge, and addresses how Major General George G. Meade organized and motivated his Army of the Potomac in response to Lincoln's mandate to bring about the "literal or substantial destruction" of General Robert E. Lee's retreating Army of Northern Virginia. As far as the president was concerned, if Meade aggressively pursued, confronted and defeated Lee before he could escape across the flooded Potomac River, "the rebellion would be over."

The commanders faced difficult tasks, including rallying of their troops for more marching and fighting. Lee had to conduct an orderly withdrawal away from Gettysburg while Meade assessed the condition of his victorious but heavily damaged army. Lee's army was still dangerous, and more than once had snatched defeat from the jaws of victory. Central to the respective commanders' decisions was information received from their intelligence-gathering resources about the movements, intentions and capabilities of their foes. The eleven-day period after Gettysburg was a battle of wits to determine which commander better understood the information he received and directed the movements of his army accordingly. Prepare for some surprising revelations.



Richard R. Schaus, Sergeant Major, US Army (Ret.), served on active duty for more than 30 years in a variety of army and joint military intelligence



assignments both at home and abroad. Rick is a lifelong student of the Civil War and American military history, and the Gettysburg Campaign in particular. Along with Thomas Ryan, he is the author of "Lee is Trapped, and Must be Taken" which was written using a host of primary sources including letters, memoirs, diaries, official reports, newspapers and telegrams. These intelligence gems form an exciting and fast-paced narrative that includes a significant amount of new information.

# **PRESIDENT'S MESSAGE**

"History is about who tells it." So says actor, rapper, singer, songwriter and film producer Daveed Diggs. Not exactly a household name, Diggs is both a Tony and a Grammy award winner having gained fame in the roles of the Marquis de Lafayette and Thomas Jefferson in the acclaimed musical *Hamilton*. (And therein he illustrates his point as a black man portraying Revolutionary War era white men!)

What Mr. Diggs should have said, though, was "*Historiography* is about who tells it." While "history" is a factual event generally not open to discussion, "historiography" is how one studies and (tries to) make sense of it. That a Civil War battle occurred in Adams County on the first three days of July 1863 is, indeed, a fact of history. Whether it was a turning point in the War, Robert E. Lee's worst-fought battle or when James Longstreet personally doomed the Southern cause depends, as Diggs says, on "who tells it."

In the modern era, there are many who suggest we are losing our history to "woke" revisionists who, as the theory goes, never read or studied history in the first place. Time was the "War for Northern Aggression" was all about state's rights; now the conflict is viewed in the more social vein as cleansing the nation from the sin of slavery (an effort that, according to some, is yet to be fully accomplished).

There have been three distinct phases of Civil War literature. The "contemporary" phase was written by those who were there, and they told the story as they saw it (or wanted to see it if you have ever read John Brown Gordon's *Reminiscences of the Civil War* or pretty much anything from Jubal Early). The "post-contemporary" phase through the first half of the 20th Century relied heavily on published and unpublished contemporary sources (which is why both Douglas Southall Freeman and Shelby Foote support Lee's "sunrise attack order" on the second of July as evidence of Longstreet's apostasy). The last phase is best described as the "objective" phase, as authors came to rely less on anecdotes and memories and more solid research to prove or disprove what was thought to be "history." The social revolution of the last decade suggests a new literary period may now be upon us, one in which the historiography approaches the facts of history from a different perspective. Uncomfortable to some, perhaps shocking to others, it may shine a new, intriguing light on the most significant event of our national story. In our quest to understand, we should welcome the chance to learn more. While historiography may change now and again, the history behind it never will.

# **February Program**

### Henry Washington Sawyer- Cape May's Civil War Hero

featuring Dave Fox

Henry Washington Saeger entered the world in 1830 near Allentown, but would venture off to find his own way as a carpenter 18 years later. Relocating to Cape May, New Jersey, he would shed his German heritage by changing his surname to "Sawyer,"

When the Civil War broke out, Henry would reach out to Governor Charles Olden even before efforts began to organize volunteers in response to



Abraham Lincoln's call on April 15th. The Governor would dispatch Sawyer to Washington with messages for Secretary of War Simon Cameron, and would subsequently be attached the the First Defenders when they arrived.

Following three-months service, Sawyer would return to New Jersey and again tender his services to Governor Olden. Commissioned a second lieutenant in the 1st New Jersey Cavalry, Sawyer would be promoted twice before being wounded and captured at the Battle of Brandy Station in June 1863. During his imprisonment, he would be placed under a death sentence in retribution for the execution of Confederate officers in Kentucky; only the Lincoln government's threat to execute W.H.F.

"Rooney" Lee, son of General Robert E. Lee, as further retaliation brought a stay for Sawyer. He would be exchanged in March 1864, eventually return to his regiment, and be mustered out of service as a brevet lieutenant colonel in the summer of 1865.

Sawyer would return to his adopted home town where he served in both public and business capacities before dying in 1893.



Dave Fox is a charter member of the First Defenders, and has presented to the group on three previous occasions. A graduate of Reading High School and Albright College, Dave is a U.S. Army veteran of the



Vietnam Conflict and a recipient of a Bronze Star. Now retired, Dave spends much of his time immersed in history with a focus on Union cavalry in Virginia (and apparently bores his devoted wife, Susan, with constant references to Civil War history!).

"Be these honorable men?" Such is a question posed at the outset of a presentation I recently developed centering around Wilbur Storey, Clement Vallandigham and Ambrose Burnside whose paths intersected during the late spring and early summer of 1863.

Burnside is a well-known actor in the drama of the Civil War, most commonly associated with the ill-fated Battle of Fredericksburg and, to a somewhat lesser extent, the tragedy of the "Crater" at Petersburg. Sometimes described as the "King of the Copperheads," Vallandigham was such a thorn in the side of the Lincoln Administration that he was banished to the South (which didn't want him, either, and promptly provided him passage to Canada!). Storey is lesser known to most students of the Civil War, but as the editor of the *Chicago Times*, the most influential newspaper outside of New York, he was a feared partisan whose virulent invective led the Democratic charge and who was (another) thorn in Lincoln's backside.

Each of these men, though, was entirely human and strongly believed in the causes he espoused. By the standard of the times, none were inherently "bad" men and certainly none could legitimately be viewed as "evil" (although one could certainly find a pretty large group of folks who would disagree). Each had a set of principles in he strongly believed and which aligned with a significant proportion of the American population. They were all men of their time, and their "honor" would collide in the Ohio River Valley in a series of incidents which, again, created another unwanted pain in the posterior of a harried Abraham Lincoln.

Today, the din of 24-hour cable news introduces us to many men and, with the progress of a century and a half, women. In our polarized society, the difference between a saint and a satanic minion often depends on just where you happen to be standing at any moment in time. Simply consider the disparity of views between our current president and his immediate predecessor. (For fun, tee up that question on any social media platform!)

If we closely study Wilbur Storey, Clement Vallandigham and Ambrose Burnside, we may find, though we disagree with their positions, their statements or their actions, there was a measure of "honor" about them which we can admire if we consider them closely and without prejudgment. How might future generations, when considering the leading personalities of today, answer the question, "Be these honorable men (and women)?"



# Unlike Anything That Ever Floated: the U.S.S. Monitor

# Featuring Dwight Hughes

The U.S.S. *Monitor* was an ingenious but hurried response to both the imminent threat of the Confederate ironclad C.S.S. *Virginia* and the growing prospect of international intervention in favor of the South by



powerful British and French ironclads. The United States Navy had no defenses against either menace, but *Monitor* would become a cultural icon of American

industrial strength and ingenuity. This largely symbolic role would far outshine her actual accomplishments beyond the single engagement that captured the imagination and changed the dynamics at sea. This presentation takes *Monitor* from her inception in the mind of a brilliant inventor through the dramatic first clash of ironclads at Hampton Roads in March 1862.



Dwight Hughes is a public historian, author and speaker. A 1967 graduate of the United States Naval Academy, he had a 20 year career as a Navy surface warfare officer and was decorated with a Bronze Star and Purple Heart. Following his retirement from the Navy, Dwight's second career was in software engineering, primarily in geographic feature naming data and electronic mapping under contract to the U.S. Geological Survey (a ridge in Antarctica is named after him for his contributions to that continent's databases!). A lover of sea and ships, Dwight has

*written several books and is a contributing author to the* Emerging Civil War. *He resides near Manassas, Virginia, with his wife, Judi, who is a retired U.S. Air Force officer.*

The company was the basic building block of Civil War armies. Commanded by a captain, regulations set the company strength at 100 souls, although in practice that number might vary slightly. Not all who enlisted would remain with the company as they might be found unfit for duty or sent back home for other reasons. Of course, the battlefield was always a source of attrition as casualties forcefully parted comrades from one another.

Veterans would talk of their shared experiences in the army. They ate at the same mess, received their orders from company officers who they often knew from home, marched together from one campaign to the next and told their stories around the bivouac fires.

A company would often number far more than 100 members. In fact, some had 500 or more during the course of their service as recruitment played a large part in filling vacant places. By the time the War ended in 1865, the muster rolls looked far different than those of the heady days of 1861. Still, the veterans would proudly recall their company and regiment until they answered their final roll call.

The First Defenders Civil War Round Table began life on April 15, 1997 a bit under company strength with just 73 "enlistees." As it progressed through 24 campaigns, its rolls would ebb and flow reaching a high of 101, and now in its 25th campaign reduced to a little more than half-strength at 53. Less than a half dozen of the original roster remain on duty... Lori Border, Jan Fisher, Dave Fox, Rodney LaPearl and Joe Schaeffer...to answer the roll call. Along the way, we've recruited many more, parted ways with some and said a final farewell to other fondly-remembered comrades. Yet still there are First Defenders who can answer "present!" when called to account.

#### **Treasurer's Report**

Treasurer's Report Tim Antosy presented his report for the March 2022 meeting. Our balance as of March 7, 2022, stood at \$3495.88 with \$308.00 ear-marked for preservation plus \$150.00 for a special project. The unencumbered balance as of March 7, 2022, is \$2937.88 There is a total of 53 paid members.

#### Preservation

Our March meeting has come and gone, and we raised a total of \$97 for Preservation from both our Book and Special Print Raffle. Thank you to all of you who continue to support our preservation efforts by purchasing raffle tickets or making donations. Also, congratulations to all of our book raffle winners. Your help and support is always appreciated!

During our March meeting we made a donation of \$200 toward the newest Matching Grant from the American Battlefield Trust of \$163 to \$1 for Civil War Williamsburg. # **April Program**

### The Hospitals of Antietam

#### featuring John Schildt

September 17, 1862 remains the bloodiest day in American history as nearly 23,000 casualties were entered on the butcher's bill along the banks of the sluggish Antietam Creek near Sharpsburg, Maryland. As with almost all battles, the majority of those casualties were wounded men who would



be in need of medical care.

Although the Confederate Army would re-cross the Potomac River into Virginia late the following day, many of its more seriously injured soldiers would be left behind along with nearly 10,000 Union men. As was becoming increasingly commonplace in the wake of battle. dozens of field hospitals would be set up in commandeered houses, barns and other available buildings. Places like the Smoketown Hospital, Poffenberger's Farm (where Clara Barton tended to the wounded), Samuel Pry's Mill, the Hoffman Hospital, the Crystal (or Locust Spring Hospital) and the German Reformed Church would become places of suffering,

refuge and in many cases the final moments of thousands. The story of the Battle of Antietam is well-known; this program tours the aftermath of that bloody day.

John Schildt has been a lifelong student of Antietam. A previous First Defenders speaker, John is a native of Maryland and a graduate of Shepherd

College and the Wesley Theological Seminary. He is both a renowned tour leader and the author of more than a half dozen books including September Echoes, Drums along the Antietam, Four Days in October, Roads to Antietam, Jackson and the Preachers, Antietam Hospitals, and Antietam Through the Years. John was the main speaker at the 125th anniversary of Antietam. While giving tours he likes to make history come alive by the information he shares of people, places and human interest stories.

There is a recently released volume in the Emerging Civil War's ever increasing library of titles: "The Great 'What Ifs' of the American Civil War." As noted on the dust jacket, "Historians tackle the conflict's most intriguing possibilities."

What might have happened in April 1862 along the Tennessee River had Albert Sidney Johnston not been killed at Shiloh? How might the Civil War have changed had Great Britain intervened either as Confederate ally or simply as a peacemaker? What if we would never have met the friends we have? What if we had never learned fascinating things we never knew? #### "The Fourth Battle of Winchester"

In 2002 renowned historian Richard McMurry published an "alternate history" in which there is a fourth battle at Winchester. His thesis, however, was to prove that victory in the Civil War would be won in the west, not the east. It's an interesting read from one of the most fascinating and humorous speakers on the Civil War circuit.

In the preface, McMurry talks about some of the counterfactual questions that have been asked of him over his past thirty years of speaking engagements. He notes he has known the answer to only five. The first is about the enigmatic Braxton Bragg (and we've all known folks who would ask this sort of question!):

- *Q:* What would have happened if Braxton Bragg had used an atomic bomb at *Perryville?*
- A: He probably would have won a clear tactical victory for the Confederates, but you can never know. Being Braxton Bragg, he might have vaporized his own army, thereby effectively ending the war in mid-October 1862.

Another "what if" has been answered by a leading Civil War historian!

# "Rally 'Round the Flag": Color Bearers at Gettysburg

#### presented by Dan Welch



Civil War color bearers played both a practical and symbolic role in the final years of Napoleonic warfare. Aligning on the colors provided soldiers with direction when smoke, noise and confusion made it difficult to hear bugle calls or the shouted orders of officers. Soldiers assigned to carry the national or state colors were honored to do so even though they did not carry weapons and were a conspicuous target for opposing riflemen. In this program, we learn more about the heroic stories of color bearers during the three-day Battle of Gettysburg.

Dan Welch is a public educator in Ohio and the former educations program coordinator for the Gettysburg Foundation. Dan holds a bachelor's degree in instrumental music education and a master's in

military history with a Civil War concentration. He is the author of "The Last Road North: A

Guide to the Gettysburg Campaign, 1863" part of the Emerging Civil War series. Dan continues to serve as a seasonal ranger at the Gettysburg National Military Park
